**Dear 608 Technician Certification Program:**

With 2017 approaching, we are writing to remind you, as an approved Section 608 Technician Certification Program, of your obligations under 40 CFR Part 82, Subpart F:

Every January 30th and July 30th, you must submit an activity report of the number of technicians tested by Technician Type, the number passing, and the percentage passing (a sample form is attached);

You must inform us when your contact information changes;

You must maintain all records for the life of your program:

- Records are: the names and addresses of all individuals taking the tests, their scores, and the dates and locations of the tests taken

If you decide to voluntarily withdraw from the Section 608 Technician Certification Program, you must forward all records to another EPA-approved program or to EPA.

Please submit activity reports electronically to: [608reports@epa.gov](mailto:608reports@epa.gov). Submitted reports will get a confirmation email reply.

We also want to bring to your attention a number of very important Section 608 Technician Certification Program changes that affect you:

- In the fall of 2016, EPA updated its regulatory requirements related to ozone depleting substances such as CFCs and HCFCs, and also extended them to substitutes such as HFCs. For more information, see: <https://www.epa.gov/section608/revised-section-608-refrigerant-management-regulations>;

The updated requirements (effective January 1, 2017) require you to provide a hand-out or electronic communication to technicians after they have taken the certification test explaining: who provided the training; who to contact with questions regarding the certification process; when they should expect to receive their score; and if they passed, their certification cards;

To more accurately reflect the knowledge needed to obtain the certification, effective January 1, 2017, you must revise your Technician Certification Cards to read: “[Name of person] has successfully passed a [Type I, Type II, Type III, and/or Universal, as appropriate] exam on how to responsibly handle refrigerants as required by EPA’s National Recycling and Emission Reduction Program.”;

Starting January 1, 2018, programs certifying technicians, excluding federally-run programs, must publish online a list of all technicians they have certified on or after January 1, 2017. Certifying organizations must update these lists at least annually. The list must include the first name, middle

initial, and last name of the certified technician, the technician's city of residence when taking the test, the type(s) of certification received, and the date each certification was received; and

In order to stay in compliance with the revised 608 regulations, starting January 1, 2017, programs certifying technicians must provide notice to technicians that such information will be published online in compliance with any other Federal, state or local regulations, and allow technicians to opt out of being included in such lists.

As noted previously, EPA is also in the process of updating the test bank questions for the 608 Technician Certification Program. We anticipate releasing the new test bank in the first half of 2017. Our goal is to have all programs using the new test bank by January 1, 2018. Please note that this update to the test bank will not affect existing technician certifications. There is no retest requirement for technicians who are already certified.
